ENVIRONMENTAL INFORMATION

Spill response: Sweep material and transfer to a suitable container for disposal.

HEALTH HAZARD DATA

Eye Contact: May cause immediate or delayed severe eye irritation.

Skin contact: May produce irritation or contact dermatitis. Hypersensitivity of the skin to certain cobalt compounds has been demonstrated. Prompt and thorough washing with soap and water will reduce or eliminate potential dermal effects.

Inhalation: Inhalation of dust or particulates may irritate the respiratory tract. Cobalt compounds are suspect carcinogens of connective tissue and lungs.

SUGGESTED FIRST AID

EYES: In case of contact, immediately flush eyes with flowing water for at least 15 minutes. Get medical attention.

SKIN: Flush with water, then wash with soap and water.

INHALATION: Move exposed individual to fresh air. Administer oxygen if needed. Call a physician.

INGESTION: Never give fluids or induce vomiting if patient is unconscious or having convulsions. Get medical attention.

REACTIVITY DATA

Hazardous decomposition products: Organic acid vapors and cobalt oxide fumes.
