4.1. Description of first aid measures

5.1. Extinguishing media

Suitable extinguishing media : Water spray. Foam. Carbon dioxide. Dry chemical.

Fire hazard : Highly flammable liquid and vapor. Irritating fumes of ethylmethylamine and organic acid vapors may develop when material is exposed to water or open flame.

Explosion hazard : May form flammable/explosive vapor-air mixture.

Firefighting instructions : Use water spray to cool exposed surfaces. Exercise caution when fighting any chemical fire.

Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid all eye and skin contact and do not breathe vapor and mist.
