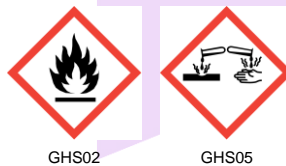

SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general : Remove contaminated clothing and shoes. In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). If possible show this sheet; if not available show packaging or label.

4.3. Indication of any immediate medical attention and special treatment needed

Note to physician- Eyes: If pain persists, repeat washing for 15 minutes or until pH of eye returns to normal. If great pain persists, place one (1) drop Benoxinate solution (0.4%) in the affected eye.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Water spray. Alcohol-resistant foam. Carbon dioxide. Dry chemical.

Unsuitable extinguishing media : Water.

5.2. Special hazards arising from the substance or mixture

Fire hazard : Highly flammable liquid and vapor. Irritating fumes of hydrochloric acid and organic acid vapors may develop when material is exposed to water or open flame.

Explosion hazard : May form flammable/explosive vapor-air mixture.

5.3. Advice for firefighters

Firefighting instructions : Do not direct water into an unignited spill. Exercise caution when fighting any chemical fire. Use water spray to cool exposed surfaces.

Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid all eye and skin contact and do not breathe vapor and mist.
