ENVIRONMENTAL INFORMATION

Spill response: May be hazardous to aquatic life if released to open waters. Cover spill with absorbent material. Transfer to a suitable container for disposal.

Recommended Disposal: Dispose of absorbent material as solid waste. Follow all chemical pollution control regulations.

HEALTH HAZARD DATA

Eye Contact: Will cause immediate or delayed severe eye irritation. The onset of irritation may not occur until several hours after exposure.

Skin contact: May produce irritation or contact dermatitis which may be delayed several hours. Prompt and thorough washing with soap and water will reduce or eliminate potential dermal effects. Organotins may be absorbed through the skin.

Inhalation: Inhalation of vapors or particulates of organotins may irritate the respiratory tract. Overexposure may produce coughing, headache and nausea. The onset of symptoms may be delayed until several hours after exposure.

Oral Toxicity: not determined

Chronic Toxicity: There are no known chronic effects related to this compound.

SUGGESTED FIRST AID

EYES: In case of contact, immediately flush eyes with flowing water for at least 15 minutes. Get medical attention.

SKIN: Flush with water, then wash with soap and water.

INHALATION: Move exposed individual to fresh air. Call a physician.

INGESTION: Never give fluids or induce vomiting if patient is unconscious or having convulsions. Get medical attention.

REACTIVITY DATA

Stability: Stable

Conditions to avoid: Combustible; avoid contact with heat, sparks or open flame.

Incompatibility (materials to avoid): Bases and reducing agents. Direct sunlight causes degradation to an inorganic tin salt.

Hazardous decomposition products: Organic Acid Vapors, tin oxides.

SPECIAL PROTECTION INFORMATION

Ventilation: Local exhaust is required. Mechanical is recommended.

Respiratory Protection: If exposure exceeds TLV air-supplied or combination organic vapor acid gas respirator.

Eye and Face Protection: Chemical worker's goggles. Do not wear contact lenses.

Other Clothing and Equipment: Rubber, neoprene or nitrile gloves. An eyewash and emergency shower should be available. Launder clothing before reuse.
